- 1. A letter of trustee nomination from the individual nominating a trustee to the Recommendation Committee supported by the following documents:
 - a. A CV of the candidate to be nominated following the suggested guidelines.
 - b. A recommendation of 500 to 600 words describing the suitability of the suggested individual for the position of the trustee of nominated category.
 - c. Consent letter from the person being nominated addressed to the Recommendation Committee explicitly stating that he/she has read the Commitments of the Candidates for Trustees.
 - d. CV of the individual nominating a trustee.

Qualifications for an Individual for Nominating a Trustee

1. Any individual is qualified for nominating a trustee.

Information to be Included in CV

- 1. Name, date of birth, residential address, country/ies of citizenship/s, gender, email, contact telephone.
- 2. Academic qualification with degree, specialization, year of degree award and degree awarding institution.
- 3. Job experience

- 4. Publications
- 5. Philanthropic activities with evidence, preferably with third party recognition.
- 6. Service to society with evidence, preferably with third party recognition.
- 7. Major achievements with evidence, preferably with third party recognition.
- 8. Leadership responsibilities with description of role, duration, institution and impact.
- 9. Information specific to various categories of trustees to be appointed.
 - a. **Professors in the area of science and technology on service or retired**
 - i. Specializations and HEIs awarding professorship and year of award, retired or on service.
 - b. Professors belonging to areas other than science and technology on service or retired
 - i. Specializations and HEIs awarding professorship and year of award, retired or on service.
 - c. Renowned individuals with experience of serving as trustees of world-class universities
 - i. Period of service (from ..to ..) as a trustee and HEI (ranked within top 200 in Academic Ranking of World-class Universities).
 - d. Former office bearers of science and technology related public institutions incorporated according to prevailing legal provisions or highly renowned individuals with at least 15 years of experience in the fields related to science and technology
 - i. Designation, name of public institution and its area of service, years of experience in the fields related to science and technology (from ..to ..).
 - e. Individuals who have attained significant achievements in enterprises related to science and technology or individuals who have made significant contribution to the University
 - i. List of significant achievement and their impact; description of the contribution made to the MBUST. Evidence of third-party recognition, if any.
 - f. Individuals who have achieved remarkable professional achievements or rendered exceptional contribution to the society
 - i. List of significant professional achievements and their impact; list of exceptional contribution to the society and their impact. Evidence of third-party recognition, if any.
- 10. Name of at least two referees, who have confirmed their willingness to provide information upon a request from the Recommendation Committee, with contact numbers and emails.

Annex 4

Commitments of the Candidates for Trustees

- 1. I acknowledge that trusteeship is a public/community/social service. I shall not seek any compensation for the time I may spend for the business of the Board of Trustees (BOT).
- 2. I shall commit to making best efforts to ensure accountability in the use of funds by the university leadership.
- 3. I shall commit to raising funds for the MBUST, including from my personal resources to the extent possible.
- 4. I shall closely monitor university activities.
- 5. I shall commit to promoting and protecting interests, norms and values of the university above any other interests including my personal interests. And in doing so I shall firmly resist internal and external pressures including those of partisan nature.

- 6. I shall not participate in any activity that constitutes a conflict of interest, and if any potential conflict of interest arises, I shall report that immediately to the BOT and the University leadership.
- 7. I shall not benefit from the position of a trustee by seeking any favors in decision making including students' enrolment, staff hiring and procurement decisions.
- 8. I shall refrain from expressing opinion that is contrary to the decisions made by the BOT.
